# **2022 SCHOOL FEES - EXISTING LEARNERS**

School fees are payable annually in advance at the beginning of each school year and as such payment is compulsory. However, in order to reduce the financial burden on parents, the school is prepared to accept payment over 3 terms.

- Term 1 No later than  $28^{th}$  February 2022
- **\*** Term 2 No later than  $31^{st}$  May 2022
- ✤ Term 3 No later than 31<sup>st</sup> August 2022

The first payment must be received by the 28<sup>th</sup> February 2022 and the last payment to be made not later than 31<sup>st</sup> August 2022.

Please note that should you be unable to make payment in terms of the above, you are requested to make an appointment via the Principal to see the Bursar before 21<sup>st</sup> February 2022 to discuss your situation and finalise a payment plan.

## PAYMENTS ARE SUBJECT TO THE FOLLOWING TERMS AND CONDITIONS :

- 1. One months' notice is necessary when taking your child out of school.
- 2. In the event of the fees being in arrears, the school reserves the right to exclude your child / ward from all school activities, lessons and examinations (as per Clause 5 of the undertaking on the Admission Form) until such time that the fees are paid or a special arrangement has been made with the school. Any such arrangement does not waive the fees and in such case it will be treated as a once-off arrangement.
- 3. The school reserves the right to issue transfer cards to learners with unpaid fees anytime during the year.
- 4. To avoid embarrassing situations please ensure that your child / ward's fees are paid timeously.
- 5. You are hereby notified that the above school fees payment supercedes any previous arrangement and / or concession including Clause 4 (Four) of the Undertaking signed by you.
